Invitation for Bids for the **Limsa -Hanesalla Road Construction (earth work track open)**

1. The **Government of Karnali Province** and **Barekot Rural Municipality** have allocated funds (60 % Province Government and 40% Barekot Rural Municipality) towards the cost of Limsa -Hanesalla Road (earth work track open) and intends to apply part of the funds to cover eligible payments under the Contract for **BRM/NCB/Works/01/2075-76**. Bidding is open to all eligible as per Section V of bidding document..
2. **Barekot Rural Municipality** invites only electronic bids from eligible bidders for the construction of **Limsa-Hanesalla road (earth work track open)** under National Competitive Bidding–Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Rs **39918518.59**
 - Minimum Work experience of similar size and nature: Minimum 12 km of Construction of Road (Either of the one as pitch, gravel or earth work) in Hilly or Mountain region and cost of minimum Rs.5,33,00,000.00
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in electronic envelope as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. Bidder who submits their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document Rs.5,000.00 which is non-refundable in the Office Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held a **Barekot Rural Municipality** at **22-03-2019** on **15:00 hours (2075/12/08 on 3:00PM)**
7. Only Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 noon** on **31st day (i.e. 02-04-2019 or 2075/12/19)** if Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 of 31st day (i.e. 02-04-2019 or 2075/12/19)** from the first publication at the office . Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf

format for e-bid, amounting to a minimum of NRS **1596740.74** which shall be valid for 120 days(i.e till 2076/04/20) after the bid opening(i.e 2075/12/19)

9. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
