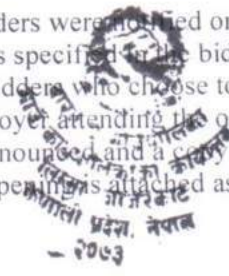
1.3 Technical Bid Opening
